Thank you for your interest in the Miami Gardens Police Department's SafeCam Program. The program is designed to provide police the ability to access your private security cameras that view public areas for the purpose of observing, interdicting and obtaining documentation of illegal activity. If you have any questions concerning the program or your involvement in it, please call the Police Department's Real Time Crime Center at (305)474-1603. To sign up for the Program, please fill out the attached application form and email it to safecam@mgpdfl.org or deliver it to the Miami Gardens Police Department located at 18611 NW 27th Ave, Miami Gardens, FL 33056.

Here are the terms and conditions of the SafeCam Program:

- The Miami Gardens Police Department obtains access to the security cameras through a dedicated URL or IP address provided by the business and/or property owners.
- Only cameras with views of public areas will be accessed by the Miami Gardens Police Department.
- The Miami Gardens Police Department may obtain a recording of observed criminal activity shown via the cameras. The cameras will be used for real-time viewing and obtaining documentation of crimes that have occurred.
- Activity in public areas will be monitored by the Miami Gardens Police Department through the private cameras as dictated by investigative needs. Participation in the SafeCam program does not imply that all cameras will be continuously monitored.
- The Miami Gardens Police Department will only store video footage of illegal activity occurring within the field of view of cameras enrolled within the program. All non-evidentiary footage will not be stored on Miami Gardens Police Department servers and will remain in custody of the owner.
- The Miami Gardens Police Department shall allow public access to all documents, papers, letters, or other materials subject to the provisions of Chapter 119, Florida Statutes, except public records which are made exempt and/or confidential from public records disclosure by law and must be protected from disclosure.
- No fee will be paid by the Miami Gardens Police Department for access to the private cameras.
- Under no circumstances shall owner construe they are acting as an agent and/or employee of the Miami Gardens Police Department through the SafeCam Program.

The Miami Gardens Police Department looks forward to working with the community through this Program. Through your participation in this Program, the Miami Gardens Police Department hopes to enhance the security and enjoyment of public areas within the City of Miami Gardens.

Recommended Setup Settings:

- Obtain and install compatible cameras from the list at
<https://www.miamigardenspolice.org/DocumentCenter/View/7422/SafeCam-Supported-Devices>
- Obtain a “Static” ip address from your internet service provider (AT&T or Comcast usually).
- Connect the cameras to your modem and assign them a port to access the cameras directly from your static IP address.
- Provide the static ip address, ports, username and password for the cameras to MGPD by emailing safecam@mgpdf.org.
